RELAXATIONS/ CONCESSIONS:

- The criteria of maximum age limit indicated above are for general category candidates. Maximum age limit is relaxable by 5 years for SC & ST category, 3 years for OBC-NCL category, 10 years for 'PwBD from UR category', 13 years for 'PwBD from OBC-NCL category' and 15 years for 'PwBD from SC/ST category' as per Govt. Guidelines. With respect to educational qualification, minimum percentage of marks required for SC/ST/PwBD candidates are 55% for all the vacancies. Other Relaxations/concessions shall be allowed as per Govt of India guidelines/PFC rules for the candidates belonging to SC/ST/OBC/PwBD/EWS/ESM categories.
- The reserved category candidates are required to submit the caste/ category certificate in prescribed format of Government of India, issued by the Competent Authority. - 2. Applications lacking supporting documents, incomplete data or received late will be summarily rejected.
- 3. All computations of age/minimum experience requirement/qualification etc. shall be done w.r.t 13 February, 2025 (last date of receiving applications). The date of declaration of result/issuance of mark sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account.
- 4. - 6. Positions are advertised for PFC, postings can be at any of the Units/Projects/Regional Offices/JVs/Subsidiaries of PFC. All posts are transferable at the sole discretion of the Management.
